

- 1. Enrollment brought in <u>8</u> students, and only had <u>1</u> transfer.
- 2. Last month we were down <u>5</u> students by cluster, this month we are down <u>2</u> students.
- 3. Enrollment worked with Principals to retain and support students that are chronically absent. This included meetings, phones calls and home visits.
- 4. Total enrollment for the district was <u>1562</u> in January and Now in February we are at <u>1568</u>.

Recruitment:

- 1. Developed and submitted budget for marketing materials to administration. Met with Ms. Steph to get budget approved.
- 2. Met with Steph and Adam to get estimates for school mailers for neighborhoods/city wide. Sonia Developed mailer. Everything has been completed on our end we are waiting on response. Will follow up because of urgency.
- 3. Our waitlist on January 13th had a total of <u>197 students</u> now since February 9th we have <u>239</u> <u>students</u> on the waitlist. The waitlist for 6th/7th/8th need improvement. Will work on improving that.
- 4. Developed Calendar for unit and other unite members to go out 3 days a week to canvass Camden neighborhoods.

Retention:

- 4. Develop orientations and open houses for current and perspective students. Focus on grades 5th,6th, 7th, 8th.
- 5. Do monthly phone blast through Maria to appreciate students, Parents and Encourage them to re-enroll their child/Children and recruit others they may know.

Through these actions the enrollment team are hoping to address the enrollment/waitlist concerns for next school year. There are concerns with grades 6th,7th,8th and it is our objective to work hard to overcome those loses before next school year 2021-2022. With marketing in the mail, social media, events and canvasing, we believe we can meet the enrollment objectives desired by the district and the LEAP family.


