School Responsibilities

- Serving to the extent possible on policy advisory groups, such as being the Title I, Part A parent representative on the school's LEAP Academy Parent Committees (ESL/ Special Education)

Student Responsibilities

The students of LEAP Academy students will be responsible to improve their academic achievement and achieve the State's high standards. To do so, the students will:

- Do homework everyday and ask for help when they need to.
- Read at least 30 minutes everyday outside of school time.
- Give to their parents or the adult who is responsible for their welfare all notices and information received by them from LEAP Academy everyday.
- Take advantage of all or any Title I programs that the school has to offer, such as: summer enrichment program, tutoring, academic resources and materials.

Title I Coordinator's Responsibilities

GENERAL EXPECTATIONS
